

## How do I get the rebate?

## How do I qualify for the rebate?

To be eligible for the rebate you need to meet certain criteria:

- The rebate is only available for existing homes in Victoria, built before 1991, and excludes new homes and additions to existing homes.
- Your ceiling must never have been insulated.
- A minimum R-Value of R3.5 ceiling insulation must be installed. The R-Value is a measure of the effectiveness of the insulation.
- The installation must be carried out by a participating installer, who has completed the required training course.
- The rebate is available for properties that are a principal place of residence including rental properties where the lessee is responsible for the energy bills.

## How much rebate can I claim?

You can claim 30% of the total cost of the installed insulation up to a maximum of \$300.

If you are a concession card holder you can claim 50% of the total cost of the installed insulation up to a maximum of \$500.
